1. Eligibility during non-exercise times for the Walker Center Billeting:

- a. All active duty military and Korean Augmentation to United States of America (KATUSA).
- b. DOD civilian who possess a proper identification and a copy of their TDY or official business orders
- c. All retired personnel and all retired DOD personnel for hospital appointment with an appointment slip form Doctor or hospital and waiting visa processing for an overnight stay in the facility.
- d. Bus drivers who providing the buses for a large group of Soldiers which will reside in the facility for an Overnight stay.

2. WALKER CENTER TRANSIT FACILITY RULES

- a. Walker Center is a 24 hour quiet facility; no unnecessary noise will be tolerated! No cell phone use, TVs or games be allowed in the sleeping area, if watching movies, headphones are required. Alarm clocks are authorized. Those who are not being considerate of others will lose their privileges to stay at the Walker Center.
- b. Beds must be made neatly. Tenants will maintain a clean and orderly sleeping area at all times. Linen must be used at all times.
- c. Do not switch bunks or wall lockers, unless told to by the CQ NCO. Remain in your assigned area.
- d. Eating or drinking is allowed only in the break room; you must clean up after yourself. Food or drinks found in the bays will be immediately confiscated and thrown out!
- e. No parking vehicles in front of the entrance area.
- f. No Smoking in the Walker Center or 50 ft. from the building. There is a designated smoking area. The use of smokeless tobacco is prohibited in the Walker Center.
- g. Possession or consumption of alcohol is strictly forbidden in and around the facility. The CQ NCO will terminate billeting for any Tenant found to be intoxicated or disorderly.
- h. Secure your gear and personal items. (Walker Center Staff is not responsible for any stolen items).
- i. No weapons or contraband are allowed in the Walker Center.

- j. No males are allowed in the female bays (E, F or G) or females in male bays (A, B, C, D or H).
- k. Phone calls in the reception area are limited to a maximum of 5 minutes.
- l. There is a designated area to iron clothes, none will be done in the bays or day room.
- m. Check out is required prior to departure.
- n. Any alcohol related incidents, including destruction or personal property or government property, urinating on personal property or Government property, or vomiting will result in the MPs being called statement of charges will be done.
- o. No sexual harassment or sexual assault in this facility or anywhere; Subject will be punishable under UCMJ.
