SUBJECT: US Army Garrison (USAG) Daegu Policy Letter #14, Youth Curfew,
Community Policy Letter

1. PURPOSE:

a. To establish and define a community youth curfew and applicable enforcement mechanisms for USAG-Daegu. These policies provide reasonable flexibility to our youth for late hour activities while ensuring a safe environment for them.

b. These policies compliment and support existing Korean youth protection laws in USAG-Daegu.

2. REFERENCES:

a. U.S. – ROK Status of Forces Agreement.

3. DEFINITIONS:

a. "Youth" refers to persons under the age of 18 years who are dependents of DoD military personnel, civilian employees, and invited contractors; retired U.S. military personnel, and widows and widowers of U.S. personnel entitled to use USFK facilities.

b. "Guests" refers to persons under the age of 18 years who are not youth and are present on USAG-Daegu installations.

4. APPLICABILITY: These policies apply to all youth, on post or off post, in USAG-Daegu. The policy also applies to guests who are present on USAG-Daegu installations.

5. POLICIES:

a. All youth must be in their residence between 2200 and 0500 daily. All guests on USAG-Daegu installations must be in a residence or in a place of lodging between 2200 and 0500 daily.

b. All youth must comply with Korean laws and not enter establishments that serve alcoholic beverages, adults only karaoke establishments, adults only PC bangs, adults only shops, and the Daegu glass house district.

c. Failure to comply with these policies may result in administrative sanctions up to, and including, early return of the youth to CONUS or USFK bar orders for guests.

6. EXCEPTIONS TO THESE POLICIES:

a. Fridays, Saturdays, and the day prior to U.S. holidays, curfew hours are from 2400 to 0500 for youth and guests who are from 16 to 17 years of age.

b. On evenings when official youth activities (Youth Services, DODDS, Boy/Girl/Cub/ Scouts, Chapel) are scheduled past the scheduled curfew; the curfew is extended to thirty (30) minutes past the event's completion time for only those youth and guests attending the activity. Normal curfew hours apply to all others.

c. When youth or guests are accompanied by a parent or legal guardian or other responsible adult designated by the parent or guardian such as a teacher, scout master, or youth leader.

7. RESPONSIBILITIES:

a. Commander, USAG-Daegu Support Activity is responsible for the operation and administration of these policies. The Commander and the Deputy to the Garrison Commander are responsible for imposing administrative sanctions for violations of these policies.


b. Directorate of Emergency Service (DES). The Military Police are responsible for enforcement of these policies. Violations on or off post will be documented and forwarded to the USAG-Daegu Law and Order Officer for action. Depending on the hour and conduct of the violations, Military Police have discretion to detain youth detected on or entering an USAG-Daegu installation until sponsors report to the military police desk to obtain custody of the youth.

c. Sponsor: Each sponsor is responsible to ensure that his/her youth are aware of and comply with these policies.

d. Youth and guests: Each youth and guest shall comply with these policies.
