SUBJECT: Weapons Carry and Storage Policy

1. In accordance with CFC EFO 07-06, dated 29 Jan 07, Weapons Immersion Policy during CFC Exercises, USAG-Red Cloud and Area I Commanders will implement a Weapons Carry Policy on all installations effective immediately as per the Enclosure.
2. Applicability: Policy applies to all USAG-Red Cloud and Area I installations and applies to all personnel carrying individual weapons.
3. General Policy Statement: In accordance with CFC EFO 07-06, all CFC personnel participating in CFC exercises are required to carry individual assigned weapons at all times. Weapons will not be carried into prohibited areas.
4. Specific Policy Guidance: The enclosure and clearing procedures will be posted at all LSA's along with a clearing barrel, instructions for weapons clearing, and an amnesty box if required. Garrison Commanders will coordinate with unit commanders to ensure their personnel understand this policy. This policy does not apply to Military Police or armed guards in the commission of non-exercise related duties.
