SUBJECT: Expeditionary Civilian Workforce Shoulder Sleeve Insignia (SSI)

1. References:

- a. Army Regulation (AR) 670-1, (Wear and Appearance of Army Uniforms and Insignia) 25 May 2017.
- b. Department of Army Pamphlet (DA PAM) 670-1 (Guide to the Wear and Appearance of Army Uniforms and Insignia), 25 May 2017.
- 2. There are two types of deployed Army civilians. The first type is recruited and hired for positions that require mobilization as part of their conditions of employment. These personnel are part of internal unit deployments. The second type is not recruited or required to mobilize in support of contingency operations; they volunteer through the Department of Defense Expeditionary Civilian (DoD-EC) Program.
- 3. To distinguish our volunteer expeditionary civilians, the Institute of Heraldry approved SSI design has been modified with the words "Expeditionary Workforce" embedded with the symbol. The SSI will be worn on the wearer's right sleeve in the Army Combat Uniform.
- 4. The Deputy Chief of Staff (DCS), G-1 is the proponent for the policies prescribing the wear and appearance of Army uniforms. The DCS, G-1 will incorporate the provisions of this approval memorandum into AR 670-1 and DA PAM 670-1 within 2 years from the date of this memorandum.
