SUBJECT: Exception to Policy for Kosovo Force's (KFOR) Request to purchase and wear a KFOR Brassard

1. Reference:

a. Army Regulation (AR) 670-1, (Wear and Appearance of Army Uniforms and Insignia), 25 May 2017

2. Your request for Exception to Policy for local purchase and wear of the KFOR Brassard is approved. Approval of this request adds a distinctive insignia that identifies the U.S. Forces as being integral to the Allied Forces comprising the Multinational Battle Group-East (MNBG-E). This insignia will also convey our commitment to operations in Kosovo while emphasizing the "Allies & Partners" pillar of the United States Army Europe (USAREUR) Strong Europe strategy. KFOR must utilize the acquisition review board process in theater in order to purchase these brassards.

3. This authorization serves as an exception to AR 670-1, paragraph 19-29. This exception expires one year after the date signed. AR 670-1, paragraph 19-29 will be updated to add the KFOR brassard to the list of authorized brassards.
